**Conditions of Registration**

In consideration of the Rockcliffe Lawn Tennis Club ("the Club") accepting the participant's application in the program, the participant agrees to adhere to all rules and regulations, policies and procedures in respect to the program and to abide by all terms and conditions of registration.

**Program Withdrawals**

The Club will charge an administration fee of \$10 plus 5% G.S.T. when a participant or parent/guardian of the participant requests to withdraw from a program 7 days or less before the program start date. The participant or parent/guardian of the participant may receive a credit on account with the Club or a refund subject to the reduction by the amount of the established administration fee provided he/she shows proof of payment.

**Returned Cheque Fee**

**A \$25.00 service fee will be levied on all cheques returned as Non-Sufficient Funds (NSF); Stop Payment; or Funds Not Cleared.**

**Severe Allergies**

It is the responsibility of the participant or parent/guardian of the participant to identify themselves or their child(ren) if they have a severe allergy and require an Epipen or have any other medical condition that the Club should know about.

**Indemnification**

I, as the participant or on behalf of the participant, agree that by registering in the program, the participant is knowingly and freely assuming certain injury and legal related risks. An individual's participation in the program will be deemed to indicate acceptance of such risks.
